**RESOLUTION 12-026**

**A RESOLUTION DETERMINING THE REQUEST FOR AN ENTERTAINMENT LICENSE BY SANIBEL HOLDINGS, INC. AT CHIP'S SANIBEL STEAK HOUSE, 1473 PERIWINKLE WAY; AND PROVIDING AN EFFECTIVE DATE**

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Sanibel, Florida:

**WHEREAS**, the applicant, Chip Durpo, President of Sanibel Holdings, Inc. d/b/a Chip's Sanibel Steak House, has filed an application requesting an indoor musical entertainment tax receipt to provide entertainment as described in Section 1 below; and

**WHEREAS**, applicant filed such request on February 29, 2012; and

**WHEREAS**, this Council has duly heard and considered this request;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Sanibel, Florida:

**Section 1.** The application of Chip Durpo, on behalf of Sanibel Holdings, Inc. d/b/a Chip's Sanibel Steak House, for an entertainment Business Tax Receipt at 1473 Periwinkle Way, Sanibel, is hereby APPROVED with the following conditions:

- a. Performances under this Business Tax Receipt are limited to no more than one performer and/or musician.
- b. Performances must be inside only and the windows and doors (except for entry and departure of individuals) of the structure shall remain closed during all performances.
- c. Entertainment must end by 11:00 P.M., Holidays 1:00 A.M.
- d. The annual Business Tax Receipt tax is \$262.50 per year.
- e. Unless the City Manager refers the matter to Council due to noise or other problems related to the Business Tax Receipt, the tax receipt may be renewed annually, at the time other Business Tax Receipts are issued without further Council action.

**Section 2.** Effective Date.

This resolution shall take effect immediately upon adoption.


