ORDINANCE NO. 11-008

AN ORDINANCE AMENDING CITY OF SANIBEL ORDINANCE NO. 07-014, AS AMENDED, WHICH ESTABLISHED MEMBERSHIP FEES FOR THE CITY OF SANIBEL RECREATION CENTER; ESTABLISHING A "MEMBERSHIP UPGRADE" FOR AFTER-SCHOOL PROGRAM PARTICIPANTS; PROVIDING FOR CODIFICATION AND SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Sanibel City Council has established the Sanibel Recreation Center Membership Fees; and

WHEREAS, the City Council finds it necessary and appropriate to amend the previously established Membership Fees as set forth in Ordinance 07-014, as amended by Ordinances 08-001, 08-007, 08-015, and 10-009;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Sanibel, that Ordinance 07-014, as amended, be further amended to revise membership fees for the City of Sanibel Recreation Center, with underlining indicating additions and strikethrough indicating deletions, as follows:

SECTION 1. MEMBERSHIP FEES.

To qualify as a **RESIDENT** (*) one of the following is required:

- Valid Florida Driver's License showing a Sanibel or unincorporated Lee County address.
- Lee County voter registration card showing a Sanibel or unincorporated Lee County address plus photo ID.
- Declaration of Domicile showing a Sanibel or unincorporated Lee County address plus photo ID.
- Property ownership records showing a Sanibel or unincorporated Lee County address plus Photo ID.

To qualify as an **ON-ISLAND EMPLOYEE**, the following is required:

- Current pay stub from on-island business plus photo ID

A **VISITOR** is any individual or family not qualifying as a Resident or On-Island Employee.

A **FAMILY MEMBERSHIP** is defined as persons living in the same household.

NOTE: Children 11 years old and younger must be accompanied by an adult and children 4 years old and younger will be admitted at no charge, provided they are accompanied by an adult with a membership.

MEMBER GUEST RATE - INDIVIDUAL shall mean the fee applicable for any member of the public who is a guest of and is accompanied by a Member who holds a valid resident daily, weekly, six month or annual membership to the Sanibel Recreation Center. Such Member Guest shall be required to display a photo ID at registration.

MEMBER GUEST RATE - FAMILY shall mean the fee applicable for two or more members of a family (defined as persons living in the same household) who are guests of, and are accompanied by, a Member who holds a valid resident daily, weekly, six month or annual membership to the Sanibel Recreation Center. Such Member Guest shall be required to display a photo ID at registration.

CITY OF SANIBEL EMPLOYEE shall mean any full-time or part-time individual employed by the City of Sanibel.

CITY OF SANIBEL RETIREE shall mean an individual who was a full-time employee with the City of Sanibel and has retired in accordance with the City's retirement provisions and is currently entitled to retirement benefits.

A CITY EMPLOYER CORPORATE WELLNESS MEMBERSHIP is defined as a pre-paid Recreation Center Membership Voucher(s) issued to a Sanibel employer, with a Sanibel business address and a Business Receipt (formerly known as an Occupational License) to conduct business within the City of Sanibel, for purposes of providing the employees of such business with a business-established Wellness Program.

A SANIBEL BASED NON-PROFIT ORGANIZATION is defined as a non-profit group or other affiliation of persons, the substantial majority of which are Sanibel residents or property owners, which has its meetings and/or fund raising activities on Sanibel, or has an equivalent physical presence on Sanibel, and whose efforts are intended to enhance the quality of life of its members and/or the general Sanibel community.

SECTION 2. This Ordinance is adopted pursuant to the authority and requirements of Sanibel Charter Section 3.11. This Ordinance is intended to fully effectuate the fees, schedules and other provisions of Ordinance 11-005, which was adopted pursuant to the emergency enactment procedures of said Charter Section 3.11 and which will stand repealed pursuant to such procedures.

SECTION 3. CODIFICATION.

This ordinance shall be deemed an amendment to the Code of Ordinances of the City of Sanibel and the Sanibel Code of Ordinances is hereby amended.

SECTION 4. SEVERABILITY.

If any section, subsection, sentence, clause, phrase or portion of this ordinance, or application hereof, is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion or application shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portion of application hereof.

SECTION 5. Effective date.



ORDINANCE 11-007 AMENDING CITY OF SANIBEL ORDINANCE 07-011, AS AMENDED, WHICH ESTABLISHED AN UPDATED AND REVISED SCHEDULE OF RECREATION USER FEES FOR CITY OF SANIBEL RECREATION PROGRAMS; REVISING AND UPDATING THE CURRENT SCHEDULE TO ESTABLISH AN "EARLY BIRD" REGISTRATION FEE SCHEDULE, ADD ADDITIONAL PROGRAMS AND AMEND FEES AS PROVIDED IN THE ATTACHED REVISED SCHEDULE; PROVIDING FOR CODIFICATION AND SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Ordinance 07-011, as amended by Ordinances 08-012, 08-018 and 09-002, established the most recent updated and revised Schedule of Recreation User Fees for the City of Sanibel Recreation Program; and

WHEREAS; the City Council finds it necessary and appropriate to update and revise the current schedule, establish an "Early Bird" registration fee schedule and add additional programs;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Sanibel, Florida:

SECTION 1. City of Sanibel Ordinance 07-011, as amended by City of Sanibel Ordinances 08-012, 08-018 and 09-002, is hereby further amended to update and revise the current Fee Schedule, establish an "Early Bird" registration fee structure and add additional programs as set forth in the attached Recreation Programs and Fee Schedule, incorporated herein and attached as Exhibit "A", with underlining indicating additions and strike-through indicating deletions.

SECTION 2. This Ordinance is adopted pursuant to the authority and requirements of Sanibel Charter Section 3.11. This Ordinance is intended to fully effectuate the fees, schedules and other provisions of Ordinance 11-004, which was adopted pursuant to the emergency enactment procedures of said Charter Section 3.11 and which will stand repealed pursuant to such procedures.

SECTION 3. CODIFICATION.

This ordinance shall be deemed an amendment to the Code of Ordinances of the City of Sanibel and the Sanibel Code of Ordinances is hereby amended.

SECTION 4. SEVERABILITY.



RESOLUTION 10-029**

A RESOLUTION AMENDING THE SCOPE OF DUTIES AND RESPONSIBILITIES OF THE PARKS AND RECREATION ADVISORY COMMITTEE; PROVIDING THAT THE MEMBERSHIP OF THE COMMITTEE SHALL BE REDUCED FROM 13 MEMBERS TO 9 MEMBERS THROUGH ATTRITION (RESIGNATION OR EXPIRATION OF TERMS); AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Parks and Recreation Advisory Committee in the past has provided various duties and functions to assist City Council in matters relating to Parks and Recreation; and

WHEREAS, through research and as a result of Subcommittee recommendation to the full Parks and Recreation Advisory Committee, it has been determined that a separate 501(3)(c) organization to assist in funding and support of Parks and Recreation activities is not warranted or desired at this time; and

WHEREAS, this results in a reduction in the necessary Scope of Duties and responsibilities of the Parks and Recreation Advisory Committee; and

WHEREAS, a strong and active volunteer program has been established with the assistance of the Parks and Recreation Advisory Committee and such program has assisted in the efficiency of the Parks and Recreation Advisory Committee; and

WHEREAS, the City Council has deemed it appropriate to revise the duties and responsibilities of the Parks and Recreation Advisory Committee and to reduce the membership of the committee through attrition as members resign or as terms expire;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Sanibel, Florida:

SECTION 1. The duties and responsibilities of the Parks and Recreation Advisory Committee are hereby amended and revised and the duties and responsibilities of such committee shall be as follows:


- (a) Encourage healthy lifestyles for Sanibel residents of all ages and fitness levels.
- (b) Monitor, review and prepare recommendations to City Council consistent with the Sanibel Plan, including the Parks Master Plan, for the programming and facilities of the City's Parks and Recreation Facilities.
- (c) Promote memberships for the Sanibel Recreation Center and Sanibel Senior Center.

SECTION 2. The membership of the Parks and Recreation Advisory Committee, currently being 13 members, shall be reduced through attrition (e.g. resignation or expiration of terms) until there are 9 seats filled and, at that time, the membership of the Parks and Recreation Advisory Committee shall be and remain at 9 members. By way of example, upon the resignation of one of the current 13 members, the seats on the committee shall be reduced to 12 seats, and such reduction shall continue in that manner until the filled or available seats are reduced to a total of 9 seats.

SECTION 3. Effective date.







NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Sanibel, Florida:



- (a) Encourage healthy lifestyles for Sanibel residents of all ages and fitness levels.
- (b) Monitor, review and prepare recommendations to City Council consistent with the Sanibel Plan, including the Parks Master Plan, for the programming and facilities of the City's Parks and Recreation Facilities.
- (c) Prepare recommendations to City Council for the long-term financial stability for the maintenance and programming of the City's Parks and Recreation facilities, including evaluating the feasibility of establishing a "501(c)3" not-for-profit corporation, e.g. "Friends of Sanibel Parks and Recreation."
- (d) Prepare recommendations to City Council regarding recruiting, recognizing and utilizing volunteers to provide citizens rewarding volunteer opportunities and improving the quality of the City's recreational programming.
- (e) Promote memberships for the Sanibel Recreation Center and Sanibel Senior Center.

SECTION 2. Effective date.



NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Sanibel, Lee County, Florida:







RESOLUTION NO. 01-39

A RESOLUTION APPROVING THE CREATION OF A PARKS AND RECREATION ADVISORY COMMITTEE TO SERVE THE CITY COUNCIL, R IN AN ADVISORY CAPACITY, ENGAGING IN AND PROVIDING EFFECTIVE CITIZEN REQUESTS, ANALYSIS AND RECOMMENDATIONS CONSISTENT WITH THE INTENT OF THE DIRECTION OF THE COUNCIL AND PARKS AND RECREATION DEPARTMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Parks and Recreation Department provides innumerable activities for the public's enjoyment on a limited budget; and

WHEREAS, it has become apparent that the Department could benefit from an Advisory Committee to enhance the services already provided by giving insight into outside budgetary funding sources such as fundraising events, grants, etc.; and

WHEREAS, such a Committee will be instrumental in providing promotion and stimulation of public interest in the City's recreational facilities; and

WHEREAS, in addition to the above, the Parks and Recreation Advisory Committee shall also perform the following:

- a. Help interpret the parks and recreational needs and desires of the community on both a short and long term basis;
- b. Study and evaluate the existing programs in the community;
- c. Act as a clearing agency for suggestions;
- d. Advise Council regarding local traditions and recreational usage patterns and offer guidance when departures from these norms are contemplated;
- e. Stimulate community members to participate in various programs by showing the values to be derived from their participation;

- f. Investigate citizen complaints and suggest ways to correct any adverse findings;
- g. Recruit volunteer leadership;
- h. Assist Council by enhancing their understanding of the public's reaction towards recreational programs.
- i. All of the foregoing shall be consistent with the Sanibel Plan.

NOW, THEREFORE, BE IT RESOLVED that the City of Sanibel creates the Sanibel Parks and Recreation Advisory Committee to perform the above listed functions and to report its recommendations to this Council.

SECTION 1. The members of this Committee shall be appointed for a term of one year and shall be composed of no more than seven (7) individuals who are residents of Sanibel and appointed by this Council based upon special knowledge, skills or interest in parks and recreation.

SECTION 2. Members of the Committee shall consist of the following but not limited to:

- a. Business Sector Representative
- b. Youth and Family Representative
- c. School Representative
- d. Senior Representative
- e. Special Needs Representative

SECTION 3. The Committee shall appoint a Chairman and a Vice-Chairman from its own membership by majority vote. The Chairman will preside at all meetings except the Vice-Chairman will preside in the absence of the Chairman. Regular meetings

may be held monthly and special meetings may be held, as necessary. The Chairman and/or a majority of the membership may set meeting dates and times. City staff shall provide public notice requirements, minute taking, and record keeping.

SECTION 4. Effective date.
