RESOLUTION NO. 12-111

A RESOLUTION APPOINTING MEMBERS TO THE CITY OF SANIBEL CONTRACTOR REVIEW BOARD; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Sanibel has established the City of Sanibel Contractors Review Board pursuant to Ordinance No. 04-005, as amended, which has been codified in the City Code of Ordinances; and

WHEREAS, said ordinance establishes criteria for the appointment of Board members;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Sanibel, Florida, that:

SECTION 1. City Council hereby reappoints the following members to the Contractors Review Board:

- (a) Jeff Molnar, as a Florida licensed Electrical Contractor
- (b) Matt Kirchner, as a Certified General Contractor
- (c) Edgar Burton, as a Florida licensed Architect
- (d) Jim Kilchenman, as a Citizen at Large




