

**FIRST AMENDMENT TO**  
**AGREEMENT FOR TOURIST DEVELOPMENT TAX FUNDING**

THIS AMENDMENT to the Tourist Development Tax Funding Agreement, dated January 8, 2013, is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2013, by and between **LEE COUNTY**, a political subdivision and charter county of the State of Florida, hereinafter referred to as the “**COUNTY**”, and the **CITY OF SANIBEL**, a municipality incorporated in the State Florida, hereinafter referred to as “**RECIPIENT**”, for additional funding provided by Lee County pursuant to its Tourist Development Plan.

**WITNESSETH:**

**WHEREAS**, the **COUNTY** and **RECIPIENT** entered into an Agreement regarding their respective duties and responsibilities for the distribution and use of Tourist Development Tax; and

**WHEREAS**, the **COUNTY** and **RECIPIENT** acknowledges that the Tourist Development Tax may only be spent in accordance with the Tourist Development Plan adopted by Lee County; and

**WHEREAS**, it is in the public interest of both the **COUNTY** and the **RECIPIENT** to amend the Agreement, dated January 8, 2013, to provide additional funding for this project; and

**WHEREAS**, the **COUNTY** has approved the **RECIPIENTS** request for funding under its Tourist Development Tax Plan for implementation of the following project:

**NAME: Sanibel Beach Erosion Monitoring**

**NUMBER: 401747**

**NOW, THEREFORE,** THE PARTIES HEREBY AGREE TO AMEND the Agreement as follows:

1. The Recitals as set forth above are incorporated into the terms of this Agreement as if set out herein at length.
2. Item 1, of the Agreement is hereby amended as follows, with underlined language being the amendment to previously adopted text and deleted language being shown by struck-through type.

The **RECIPIENT** will perform the work as outlined in the project description and submit a detailed invoice to the **COUNTY**. The **COUNTY** will then reimburse the **RECIPIENT** for the amount not to exceed ~~\$40,000.00~~ \$80,000.00 during the **COUNTY'S** fiscal year 2013.

3. All of the remaining terms in the Agreement, dated January 8, 2013, attached hereto, remain the same.
