ORDINANCE 08-012

AN ORDINANCE AMENDING CITY OF SANIBEL ORDINANCE NO. 07-011 WHICH ESTABLISHED AN UPDATED AND REVISED SCHEDULE OF RECREATION USER FEES FOR CITY OF SANIBEL RECREATION PROGRAMS; PROVIDING FOR THE ESTABLISHMENT OF RECREATION USER FEES FOR CITY OF SANIBEL RECREATION PROGRAMS FOR FISCAL YEAR 2008-09; AUTHORIZING THE CITY MANAGER TO APPROVE NEW ADDITIONAL RECREATION PROGRAMS DURING FISCAL YEAR 2008-09 AND ESTABLISH FEES FOR SUCH PROGRAMS, PROVIDED THE FEES ESTABLISHED DO NOT EXCEED THE COST OF OPERATION OF THE PROGRAM; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Council finds it necessary to revise and update the Schedule of Recreation User Fees for the 2008-09 fiscal year; and

WHEREAS, it is recommended that the City Manager be authorized to approve any new additional Recreation Programs during the 2008-09 fiscal year and establish fees for such programs, provided the fees established do not exceed the cost of operation of the programs; and

WHEREAS, the proposed Recreation Programs and Fee Schedule for fiscal year 2008-09 is set forth as Exhibit "A", which is attached hereto and incorporated herein, with underlining indicating additions and strikethrough indicating deletions.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Sanibel, Florida:

SECTION 1. The Recreation Programs and Fee Schedule set forth as Exhibit "A" is hereby adopted and such fees shall become effective October 1, 2008.

SECTION 2. The City Manager is hereby authorized to approve any new additional Recreation Programs during the 2008-09 fiscal year and establish fees for such programs, provided the fees established do not exceed the cost of operation of the programs.

SECTION 3. Effective Date.

This Ordinance shall take effect immediately upon adoption, with the Recreation Programs and Fee Schedule as set forth on Exhibit "A" becoming effective on October 1, 2008.
