Listed Contractors have expressed interest in conducting Brazilian pepper eradication work and have signed an Agreement with the City acknowledging the critical components for successful management of Brazilian pepper: 1) Permitting; 2) Pepper clearing; 3) Herbicide application (copy of State license on file with Natural Resources Department); 4) Debris removal; and 5) Re-treatment.
