

CITY OF SANIBEL
ORDINANCE NO. 16-007

AN ORDINANCE AMENDING THE CODE OF ORDINANCES, CHAPTER 90 - FEES, ARTICLE V. RECREATION USER FEES, DIVISION 1 – SANIBEL RECREATION CENTER, SECTION 90-501 – RECREATION USER FEES; PROVIDING FOR AN INCREASE IN MEMBER USER FEES AND INCREASE IN NON-MEMBER USER FEES; PROVIDING FOR CODIFICATION AND SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Sanibel City Council has established the Sanibel Recreation Center Recreation User Fees and such User Fees have been codified as part of the Sanibel Code of Ordinances; and

WHEREAS, the City Council finds it necessary and appropriate to amend the previously established User Fees by increasing member user fees and increasing non-member user fees as recommended by Staff (both rounded to the nearest dollar);

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Sanibel, Florida, that:

SECTION 1. Chapter 90 – Fees, Article V. Recreation User Fees, Division 1 – Sanibel Recreation Center, Section 90-501 – Recreation User Fees, be amended as set forth in the attached Recreation Programs and Fee Schedule, incorporated herein and attached as Exhibit “A”, with underlining indicating additions and strike-through indicating deletions.

SECTION 2. CODIFICATION.

This ordinance shall be deemed an amendment to the Code of Ordinances of the City of Sanibel and the Sanibel Code of Ordinances is hereby amended.

CANCELLATION FEES:

If participation in any program is cancelled more than 7 calendar days prior to the commencement date of the program, a 5% cancellation fee of the amount of such program will be charged to the person(s) canceling participation in the program.

If participation in any program is cancelled 7 calendar days or less prior to the commencement date of the program, a 10% cancellation fee of the amount of such program will be charged to the person(s) canceling participation in the program.


SECTION 3. SEVERABILITY.

If any section, subsection, sentence, clause, phrase or portion of this ordinance, or application hereof, is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion or application shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portion of application hereof.

SECTION 4. Effective date.

This Ordinance shall be effective immediately upon adoption provided, however, the fees set forth herein shall become effective on October 1, 2016.
