A RESOLUTION DESIGNATING THE CITY MANAGER, FINANCE DIRECTOR, PUBLIC WORKS DIRECTOR AND THE ADMINISTRATIVE SERVICES DIRECTOR TO ACT ON BEHALF OF THE CITY TO EXECUTE INVESTMENT AND BANK ACCOUNT SIGNATURE CARDS, BANKING RESOLUTION AND CERTIFICATE OF INCUMBENCY, AND RELATED DEPOSIT ACCOUNT DOCUMENTATION; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Sanibel wishes to designate the City Manager, Finance Director, Public Works Director and Administrative Services Director to act on behalf of the City to execute investment and bank account signature cards, Banking Resolution and Certificate of Incumbency and related deposit account documentation; and

WHEREAS, in accordance with the City's Investment Policy as adopted by Resolution No. 96-85 the City Manager and Finance Director are authorized and designated to act on behalf of the City with respect to the implementation and maintenance of the City's investment program; and

WHEREAS, the Finance Director shall be responsible for maintaining relationships with the various banks and other financial institutions with whom the City conducts business regarding investments and cash management; and

WHEREAS, such activities may include, but not be limited to, regular and customary activities such as: custody of securities, cash management, payroll activities, and periodic less frequent activities such as: maintenance of letters of credit or special projects; and

WHEREAS, such activities necessitates executing and amending various bank account authorization documents;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Sanibel, Florida:

SECTION 1. City Manager Judith A. Zimomra, Finance Director Sylvia A. Edwards, Public Works Director Gates Castle and Administrative Services Director James Isom, are hereby designated as the authorized City personnel to execute investment and bank account Signature Cards, Banking Resolution and Certificate of Incumbency and related deposit account documentations.

SECTION 2. Effective date.

This resolution shall take effect immediately upon adoption.


