### **Program proposal**

As requested by many parents of school age children, the "Fun Days" program is designed to provide structured and fun activities for students of working parents, K through 8<sup>th</sup> grade, from 8:00am to 5:30pm on non-school days. Examples are in service days, hurricane make up days, federal and state holidays or other non school days. The days that the Fun Days would not be provided are on Thanksgiving, Christmas, New Years and Memorial Day. The program activities would be similar to the Summer Wrec program and Holiday Fun Camps currently offered at the Recreation Center. Pre registration would be expected so staffing levels could be determined.

### **Funding**

The funding for the program would come from user fees. The fees are based on the direct cost of operating the program, which includes the cost of counselors, crafts, activities and snacks. Each student is expected to bring their own lunch. A pro rate fee of the Summer Wrec program was used along with indirect cost of registration and miscellaneous expenses. The cost for one day is recommended to be \$20 for members and \$25 for non members.

### **Next Step**

This program opportunity was announced to the Parks and Recreation Committee with consensus approval. If Council approves the Fun Days program, it would start immediately with the first school day out opportunities being November 10<sup>th</sup> and 11<sup>th</sup>.

**ORDINANCE 08-018 AMENDING CITY OF SANIBEL ORDINANCE 07-011, AS AMENDED, WHICH ESTABLISHED AN UPDATED AND REVISED SCHEDULE OF RECREATION USER FEES FOR CITY OF SANIBEL RECREATION PROGRAMS; PROVIDING FOR THE ESTABLISHMENT OF AN ADDITIONAL RECREATION PROGRAM TO BE KNOWN AS “FUN DAYS” IN ORDER TO PROVIDE RECREATION ACTIVITIES ON THOSE WEEKDAYS WHEN THE RECREATION CENTER IS OPEN BUT SCHOOL IS NOT IN SESSION; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Ordinance 07-011, as amended by Ordinance 08-012, establishes the most recently updated and revised Schedule of Recreation User Fees for the City of Sanibel Recreation Program; and

**WHEREAS**, the City Council finds it necessary and appropriate to establish an additional Recreation Program to be known as “Fun Days” in order to provide structured recreation activities at the Sanibel Recreation Center on those weekdays when the Recreation Center is open but school is closed for “in service” days, make-up days, federal and state holidays when the Recreation Center is open but school is closed, and other non-school days; and

**WHEREAS**, the City Council finds that such a recreational program provides needed assistance to working parents and their kindergarten through 8<sup>th</sup> grade children;

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Sanibel, Florida:

**SECTION 1.** City of Sanibel Ordinance 07-011, as amended by City of Sanibel Ordinance 08-012, is hereby further amended to establish an additional program as set forth in the attached Recreation Programs and Fee Schedule, incorporated as Exhibit “A”, with underlining indicating additions and strike-through indicating deletions.

**SECTION 2. Effective Date.**

This Ordinance, and the program and fees set forth herein, shall become effective immediately.
