**RESOLUTION 08-160**

**A RESOLUTION RE-APPOINTING AND APPOINTING MEMBERS TO THE CITY OF SANIBEL CONTRACTORS REVIEW BOARD; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Sanibel has established the City of Sanibel Contractors Review Board pursuant to Ordinance No. 04-005, as amended; and

**WHEREAS**, said ordinance establishes criteria for the appointment of Board members; and

**WHEREAS**, Ordinance No. 04-005, as amended, provides that the membership of the Board shall include (1) a licensed general, building, or residential contractor; (2) a licensed electrical contractor; (3) a licensed plumbing contractor; (4) a licensed mechanical or air conditioning contractor; and (5) two citizens with no contractor industry involvement; and

**WHEREAS**, the City Council wishes to reappoint three current members of the Contractors Review Board who are contractors for a term of four (4) years each; and

**WHEREAS**, the City Council wishes to appoint a non-contractor citizen member for a two (2) year term;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Sanibel, Florida, that:

**SECTION 1.** City Council hereby re-appoints the following members of the Contractors Review Board each for a four (4) year term as set forth below:

- (a) Paul Martin, as the licensed mechanical or air conditioning contractor, for a term commencing December 8, 2008 and ending on December 7, 2012;
- (b) Jeff Molnar, as the licensed electrical contractor, for a term commencing December 8, 2008 and ending on December 7, 2012;
- (c) Matt Kirchner, as the licensed general, building, or residential contractor, for a term commencing December 8, 2008 and ending on December 7, 2012.

**SECTION 2.** City Council hereby appoints \_\_\_\_\_ as a citizen member with no contractor industry involvement for a term of two (2) years commencing December 8, 2008 and ending on December 7, 2010.

**SECTION 3.** Effective Date.

This Resolution shall take effect immediately upon adoption.




