WHEREAS:

Robert "Bob" Duffy was employed by the City of Sanibel as the Planning Director on November 28, 2005; and

WHEREAS:

Bob Duffy has led the successful completion of numerous key projects during his tenure of employment, such as the 2007 Update of the Sanibel Plan; comprehensive amendments to the Land Development Code's Commercial Zoning regulations; formulation of the Town Center commercial redevelopment policies and design guidelines; introduction of revised development permitting processes and procedures to ensure consistent and timely service; initiation of improvements to the HTE permitting management system and the GIS Needs Assessment in conjunction with the MIS Department; completion of the final draft of the 2009 Shared Use Path Master Plan; and the recent submission of the Sanibel Plan amendments to address capital improvement programming, water supply and school concurrency; and

WHEREAS:

Director Duffy represented the City of Sanibel at the American Planning Association's Annual Planning Conference where the Sanibel Plan received the 2007 National Planning Landmark Award for its historic planning vision and commitment to implement that vision; and

Under Bob Duffy's leadership, the Planning Department has achieved its important mission and priorities established by City Council, the Planning Commission and the City Manager; and

WHEREAS:

Bob Duffy will resign his employment with the City of Sanibel on March 16, 2009 to pursue a new career opportunity with the Maryland-National Capital Park and Planning Commission.
