

Advertisement for Bids

The City of Sanibel is currently soliciting bids from firms interested in providing equipment and personnel to mow within the City's public rights-of-way.

The work will be assigned a week in advance and monitored by a City representative and will be done on an "as needed" basis. The successful bidder will have a person assigned to represent the company and to receive work assignments from the City's representative. This person will be available anytime the company is working for the City.

The bid quote will include all costs for supervision, insurance, overhead, profit, fuel, etc. Required insurance will include Worker's Compensation and Employer's Liability, Comprehensive General Liability and Automobile Liability in amounts not less than \$500,000 for any one person, \$500,000 for any one accident, and \$300,000 for property damage, and Excess Liability Umbrella Insurance in the amount of not less than \$2,000,000. Contract to be effective October 1, 2009 through September 30, 2014.

The contractor will be required to be licensed to work in the City of Sanibel and follow all City regulations. The following safety and time of work regulations are of special note:

1. Proper advance warning signs and lane marking cones are required per State and Federal Standards anytime work is being performed by the contractor.
2. Work shall begin no earlier than 7:00 AM and be completed no later than 5:00 PM, Monday through Thursday, only. No work on City-recognized Holidays.

The approximate time spent by City personnel annually on mowing is 3040 hours.

Proposals are due no later than 5:00 PM on June 5, 2009
