RESOLUTION 10-102

A RESOLUTION CALLING FOR AN ELECTION ON TUESDAY, MARCH 1, 2011 FOR SANIBEL CITY COUNCIL MEMBERS; SETTING THE DATE AND POLLING PLACES FOR THE ELECTION; PROVIDING FOR BALLOT LANGUAGE; REQUESTING THE LEE COUNTY SUPERVISOR OF ELECTIONS TO CONDUCT THE ELECTION AND CERTIFY THE RESULTS TO THE SANIBEL CITY COUNCIL; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Sanibel Code, Part 1 – Charter, Article III, *Legislative*, Section 3.02 *Election and Terms*; provides that the regular election of City Council members shall be held on the first Tuesday in March, in the manner provided in Article V of the Charter, and shall be for four-year terms; and

WHEREAS, it is necessary, appropriate and proper that this Council set the date and place for the election, and adopt the form of the ballot;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Sanibel, Florida:

SECTION 1. There shall be on Tuesday, March 01, 2011, by qualified electors with the municipal boundaries of the City of Sanibel, Florida, an election for the office of Sanibel City Council for two seats.

SECTION 2. The polling places of said election shall be:

Precinct 16 Senior Citizens Center
2401 Library Way
Sanibel, Florida 33957

Precinct 117 The Sanibel Community Church
1740 Periwinkle Way
Sanibel, Florida 33957

Precinct 118 Sanibel Congregational United Church of Christ
2050 Periwinkle Way
Sanibel, Florida 33957

SECTION 3. The Lee County Supervisor of Elections is requested to cause the necessary ballots to be prepared and delivered to the Clerk of the polling places. The form of the ballots shall be in accordance with ballot forms used by the Supervisor of Elections and shall be, in substance, as follows:

**OFFICIAL BALLOT, SANIBEL MUNICIPAL ELECTION
LEE COUNTY, FLORIDA
MARCH 01, 2011**

**SANIBEL CITY COUNCIL SEATS
VOTE FOR TWO**

[Note: The qualifying candidates' names will be determined as a result of the qualifying period beginning noon on January 10, and ending noon on January 14, 2011, and such candidate names will be inserted on the Ballot by the Supervisor of Elections]

SECTION 4. The Lee County Supervisor of Elections is requested to publish notice of the general election in accordance with general law.

SECTION 5. The Lee County Supervisor of Elections is requested to cause the necessary absentee ballots to be prepared and make provisions for the distribution and voting of the absentee ballots.

SECTION 6. The Lee County Supervisor of Elections is requested to cause the ballots to be canvassed and to certify same, and in turn, certify the election results to the Sanibel City Council. The Council shall declare the results thereof, and such returns shall be recorded in the minutes of the City Council at the first meeting after such certification.

SECTION 7. The appropriate election officials shall permit voting in the Sanibel Municipal Election only by qualified registered electors within the precincts whose names appear on the list of qualified registered electors as furnished by Lee County Supervisor of Elections.

SECTION 8. Effective date.
This resolution shall take effect immediately upon adoption.
